## TERMS & CONDITIONS

1. Contractors would be required to register on the e-Procurement Market place at the 'e' market Place [www.eprocurement.gov.in](http://www.eprocurement.gov.in) in addition to their respective registration and submit their Bids online. The tenders can view / download the tender schedules from the 'e' market place [www.eprocurement.gov.in](http://www.eprocurement.gov.in) at free of cost.
2. **Charges payable to M/s. C 1 India Private Limited:**  
The participating bidders will have to pay transaction fee @ 0.03% of ECV (Estimated Contract Value) + 12.00 % GST over transaction fee to M/s. C 1 India Private Limited. All the participants shall electronically pay the transaction fee to the service provider through "Payment Gateway Service on eprocurement platform". The Electronic Payment Gateway accepts all Master and Visa Cards issued by any bank to facilitate the transaction.
3. If any successful bidder fails to submit the original hard copies of uploaded certificates / documents, EMD Amount paid through on line payment within the stipulated time or if any variation is noticed between the uploaded documents and the hard copies submitted by the bidder, the successful bidder will be suspended from participating in the tenders on e-procurement platform for a period of 3 years.  
The e- Procurement. System would deactivate the user ID of such defaulting successful bidder based on the trigger / Recommendation by the tender Inviting Authority in the system. Besides this, the Department shall invoke all processes of law including criminal prosecution of such defaulting bidder as an act of extreme deterrence to avoid delays in the tender process for execution of the development schemes taken up by the Government. The information to this extent may be displayed in the e-procurement platform website.
4. **Submission of Bids:** - The bidders who are desirous of participating in 'e' procurement shall submit their technical bids, price bids etc., in the standard formats prescribed in the tender documents, displayed at 'e' market place.
5. The tenderer is subjected to be black listed and the EMD forfeited if he is found to have misled or furnished false information in the forms / statements / certificates submitted in proof of qualification requirements or record of performance such as abandoning of work not properly completed in earlier contracts, inordinate delays in completion of the works, litigation history and / or financial failures and / or participated in the previous tendering for the same work and had quoted unreasonable high bid prices. Even while execution of the work, if found that the contractor has produced false / fake certificates of experience he will be black listed and the contract will be terminated.
6. APSRTC reserves the right to cancel, split and award / post pone / reject any, or all the tenders in part or full without assigning any reason what so ever. No correspondence will be entertained in this regard. Any claim by any tenderer in regard to their investment in submission of their tenders will not be entertained.
