TENDER NOTIFICATION

Sealed Tenders in the prescribed Form are invited from the experienced and interested Man Power Supply Agencies / Contractors registered with Labour Department, who are in possession of individual Code Numbers of PF & ESI to provide persons required to carryout the works (activities) of **PARAMEDICAL STAFF** at **CENTRAL HOSPITAL, APSRTC, Vidyadharapuram, Vijayawada** purely on Outsourcing basis.

Man Power Supply Agencies / Contractors without PF Code Number can also participate in the Tender subjected to the condition that their Tenders will be considered in case of non-availability of Contractors who are in possession of PF / ESI Code Numbers from among the Tenders / Bidders.

- 1) Nature of Work : Supply of Man Power to perform duties at **CENTRAL HOSPITAL, A.P.S.R.T.C., VIDYADHARAPURAM, VIJAYAWADA** purely on Outsourcing basis.
  
- 2) Man Power :

- 3) Place of Work : **CENTRAL HOSPITAL, APSRTC, VIDHYADHARAPURAM, Vijayawada.**
  
- 4) Minimum Value (remuneration) for each category of **PARAMEDICAL STAFF** for the work contract including PF, EDLIF, ESI and 7% Profit Margin of the Contractor. The Minimum Wage ( Base wage + Cost of Living Allowance) varies from time to time depending upon the cost of Living Allowance as declared by the Labour Department from time to time.



5) **Period of Work Contract** :  
Initially for a period of ONE (1) YEAR from the date of Agreement which can be extendable for One more year (i.e., 2<sup>nd</sup>), subject to satisfactory performance of work contract as per the existing Terms and Conditions as on that date.

6) **Earnest Money Deposit Payable** : Rs.1,67,460/- drawn in favour of CHIEF ACCOUNTS OFFICER, APSRTC, RTC HOUSE, VIJAYAWADA. Payable at VIJAYAWADA.

II) **The prescribed tender Form / Application can be had from the Office of the Chief Personnel Manager, APSRTC, RTC House, Vijayawada – 520013, between 10.00 Hours and 17.00 Hours on all working days from 15.06.2018 to 28.06.2018 on payment of Rs.1770/- (including 18% GST ) per each Application.**

- 7) The Tenderer shall quote monthly remuneration expected per person, which shall include Minimum Wage Payable to the persons engaged, Statutory contributions payable towards PF, ESI and EDLIF for two aspects of item (A) or item (B) of Para No. (4) (above), whichever is applicable.
- 8) Finalization of Tenders will be by way of negotiations by the Tender Committee with the Tenderers / Bidders and decision of the Tender Committee in this regard shall be final.
  - (a) If any contractor quotes less than the minimum quotable amount estimated / notified values (remuneration) in the Tender Form, such Tender / Bidder will automatically be disqualified in the Tenders and shall not be considered / entertained by the Tender Committee.
  - (b) The Tenderer / Bidder has to quote the rate per person with PF or without PF according to eligibility with ESI at (A) or (B) of Para No. (4).
  - (c) Other things being equal, the Tenderer who is holding PF and ESI Code Numbers shall be given preference over those who have not possessed the same.
  - (d) In case there are more than one Tenderer quoting the same lowest amount, allotment of the work contract shall be made on the basis of **LOTTERY**.
  - (e) If the lowest monthly remuneration quoted by any Tenderer not holding PF Code Number is less than the monthly remuneration quoted by the Tenderer with PF & ESI Code Numbers, the Tender Committee shall have the right to negotiate with the Tenderer / Bidder having PF & ESI Code Numbers for reducing the monthly remuneration so as to give preference to such Tenderer / Bidder.
- 9) **The Tender Forms duly filled-in shall be submitted by dropping in the Tender Box kept in the Office of the Chief Personnel Manager, APSRTC, RTC House, Vijayawada – 520013 from 10.00 Hrs., to 14.00 Hrs., on 29.06.2018 and the same will be opened at 15.00 Hrs., on 29.06.2018 in the presence of the Tenderers or their authorized representatives.**
- 10) A detailed "Terms & Conditions" relating to the above mentioned Work Contract will be supplied along with the Tender Form / Application for strict compliance.
- 11) The Corporation has the right to cancel / reject all the Tenders or any Tender without assigning any reason or any notice and consider any of the Tender or one of the Tenders filed without mentioning any reason or notice.
- 12) The Corporation reserves the right to cancel the Tender process at any point of time without assigning any reason or Notice.
- 13) The Corporation has the right to extend the last date of sale of application or date of last filing / opening of Tenders without any notice or assigning any reason.
